Texoma Casino

Official Rules

1. Texoma Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Texoma Casino is giving away \$6,500 in Cash throughout the “Bourbon Street Hot Seats” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Texoma Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Hot Seat Drawings will take place on Tuesdays in March of 2019 from 6 p.m. to 9 p.m. \$1625 each night will be given away as fifteen (15) winners spin the Spin Wheel to determine their cash prize. Cash prizes will include: three (3) \$25, three (3) \$50, four (4) \$100, four (4) \$150 and one (1) \$400.
 - a.) Patron(s) must be present and actively playing at the time of drawing to be eligible for cash prize.
 - b.) Winners will be allowed one (1) spin on our Spin Wheel to determine their prize amount.
 - c.) Limit of one (1) cash prize per patron per night, during the promotion.
 - d.) Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are eligible to redeem these offers for additional entries.
 - e.) Texoma Casino’s manual drawing system will be the sole determinate of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for the Chickasaw Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Chickasaw Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
