

**Gift of the Month**  
**July – August -- September 2019**  
**Texoma Casino**

**Official Rules**

1. Texoma Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Texoma Casino is giving away a featured gift every month for the “Gift of the Month” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Texoma Casino Players Club Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Texoma Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. During the months of July, August and September 2019, all Patrons who earn the required point levels, during qualifying time periods, will be able to redeem those points for the follow prizes:
  - Level 1: 100 points for \$10 in Texoma CTS Bucks
  - Level 2: 200 points for featured gift valued between \$24 and \$70 dollars.
  - a.) Patrons must earn points on their Texoma Player Club Card by playing Electronic Games during the qualifying time period. Qualifying time periods are 8:00am Sunday through 11:59pm Saturday each week durng the promotion.
  - b.) Once Patrons have reached the required point levels they must report to the Cashiers Cage to receive their prize.
  - c.) Texoma CTS Bucks must be spent at Texoma CTS for the full amount of the certificate no change will be given on a CTS Bucks purchase. CTS Bucks cannot be used to purchase Cigarettes or Beer.
  - d.) Patron(s) must be present to redeem gift and vouchers.
  - e.) Limit of one (1) Gift, per tier, per Patron during each date range.
  - f.) Texoma Casino management may substitute any prior Gift of the Month Gift for the current month’s Gift based on availability. CTS Bucks are not be eligible for substitution.
  - g.) Texoma Casino’s casino management system will be the sole determinant of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
