

**Senior Day
Texoma Casino**

Official Rules

1. Texoma Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Texoma Casino is giving away over \$3,000 in cash and CTS Bucks throughout the “Senior Day” promotion.
2. Patrons must be fifty (50) years of age or older with a valid photo I.D. and must be a Texoma Casino Players Club Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Texoma Casino, employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities, or any promotional sponsors.
3. Beginning on January 5, 2020 through March 29, 2020, Senior Patrons who earn ten (10) points on their Texoma Casino Player Club Card during the qualifying time periods, will be eligible to receive \$5 in CTS Bucks and an entry into the hopper drawing.
 - a. Qualifying time periods are 8:00 a.m. to 8:00 p.m. each Sunday.
 - b. Patron(s) may earn points on their Players Club Card between the qualifying times. Once the minimum points have been earned, Patrons must report to the Cashier Cage to receive their voucher and entry.
 - c. Vouchers are redeemable at the Texoma CTS for food, gas, and retail. Not valid for Alcohol or Tobacco purchases.
 - d. Entry tickets must be filled out legibly and placed into the designated hopper on the date they are issued, or they will be deemed invalid.
4. Drawings will be held at 8:00 p.m. each Sunday (January 5, 12, 19 and 26, February 2, 9, 16, and 23, March 1, 8, 15, 22, and 29). Five (5) winners will be chosen and each will receive a \$50 cash prize.
 - a. Patrons do not need to be present to win.
 - b. Winner(s) will be contacted by Texoma Casino and will have seven (7) days from time of drawing to claim their prize.
 - c. Any unclaimed prizes will be forfeited.
 - d. Texoma Casino’s manual drawing system will be the sole determinate of each cash prize winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form when applicable provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before the prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry,

and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from gameplay, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
